- **11. Laggan Community Action Plan -** Active Travel/Connecting Laggan, CNPA (Cairngorms 2030), Christmas Lights, Village Amenity Group, Public Toilet
- Youth club is proving to be a great success. The club was something that Fiona Grant asked for the CC's help with setting up as somewhere safe for the children to come together on the dark winter nights. We will continue to be present at the club meetings for December and in January will hand over to the parents to continue. Thanks to Amanda for the arts and crafts ideas and for providing the paints, pens, stones etc.. Thanks also to the parents who have attended each week and given us valuable help with the games and, quite literally, the running around.

There is a bank account still in existence which was set up for the Laggan Youth Club many years ago and we have been given the relevant information to have the signatories changed so that this account can be accessed and continue to function for the new club. We will pursue this in the new year so that it can be managed via the SCIO which is currently in the process of being set up.

- Christmas Lights New Christmas lights were a must this year and so many of the locals have pulled together to make this happen. Fiona Grant requested that the children be involved in the Christmas decorations this year and as such we supplied and planted mini trees along with new lights.
 - Thanks to Alistair Todd, Hazel and David Narro and Fiona and John Grant for obtaining the various lights, to John Grant and Paul Atkinson for siting one of the village trees in Gergask Avenue. Thanks also go to Kevin and Sonya Fletcher for siting the main village tree at the Coffee Bothy and for hosting the lighting up ceremony which was very well attended, the weather was kind and it was warm enough for everyone to be outside to enjoy the occasion. Everyone was so very generous with the charity collection made for CRY, thank you all. Just to note all bringers of light will be reimbursed by us.
- CNPA Dan Harris from CNPA attended our meeting with the purpose of talking to us
 about the CNPA Local Development Process. In this first year there will be stakeholder
 and public engagement along with presentations to schools and young people in the
 park. They will be utilising Community Action Plans in order to better engage with the
 various communities. Adoption of the new plan is proposed for 2027.
 - AT questioned Mr Harris at length about how this LDP would actually benefit Laggan and the surrounding area. What is actually being done by the CNPA to deal with the real-life issues that many smaller communities such as Laggan are facing. He asked what was being done to support our stance on particular, current planning applications as we feel as a community that there is little or no support to back us and our opinions up. The CNPA is such a large organisation and certainly their "voice" will have more impact within the planning department that ours.

We as a community do want to work closely with the CNPA and give support to their ongoing LDP but we would like this to be a two-way street. Mr Harris took on board our issues and offered several suggestions about how we may deal with particular issues. He does understand the need for more support and advice on matters that are simply beyond our remit and capacity. We look forward to hearing any proposals from CNPA as a result of this meeting.
